**Policy Statement:**

In 1995, member schools of WIAA were given local control on the option of allowing nonpublic school students to participate in athletics at the middle school level. The Hortonville Area School District has decided to permit nonpublic school participation.

**Rationale:**

Students benefit from this policy through participation in activities not provided by their school of choice.

**Scope:** Students within the Hortonville Area School District attending nonpublic schools


**Responsibility:** Middle School Administrators and Activities Director

**Implementation:**

1. Any nonpublic student may participate on a WIAA public school team only if the nonpublic school is a member of the WIAA.
2. Only sports that a given nonpublic school does not offer will be made available to students from that school.
3. All students are required to have results from a physical exam every two years on file in the Middle School Office. A Green WIAA card is necessary. On alternate years, the Alternate Year Athletic Permit Card is required. Cards are available in the Middle School Office. Cards must be on file in the Middle School Office prior to practice/participation.
4. Students are allowed to use the activity bus after practice.
5. The Hortonville Area School District will not create a special transportation option for students from the nonpublic schools.
6. Students are required to follow Hortonville Middle School and Greenville Middle School academic requirements outlined in the Middle School Co-Curricular Code.
7. Hortonville Area School District coaches will send information concerning each sport to all nonpublic schools.
8. This privilege is contingent upon adherence to the rules and policies of the Hortonville Area School District.
9. A minimum of thirty (30) days prior to the start of any athletic season, nonpublic schools must make a formal, written request to the HASD Activities Director requesting participation in the specific sport for the upcoming season. Included in the request shall be the names, resident school district, addresses and grade levels of all students requesting participation.
10. Prior to the start of the season, administration of the both middle schools and the activities director will make a final determination whether the addition of nonpublic athletes will significantly impact the size of the public school teams. The administration for the public schools have the final say in determining a "reasonable team size".


